MINUTES OF THE REGULAR MEETING OF THE BOARD OF SCHOOL DIRECTORS

February 21, 2024

1. Call to Order / Pledge of Allegiance

The West Allegheny Board of School Directors met in regular session on Wednesday, February 21, 2024, in the District Office Board Room located at Wilson Elementary School. The President, Mr. Robert Ostrander, presided. The meeting was called to order at 6:58 p.m., followed by the Pledge of Allegiance.
